CONDITIONS

1. RULES. The tournament will be played under WSF rules, WA Squash Tournament By-Laws (as set out in the Junior Tournament Package and Junior Tournament Circuit Guidelines) and, where relevant, WA Squash Pennant By-Laws.
2. CLOTHING. Clothing, as provided for in the WA Squash Tournament Clothing Regulations, is to be worn.
3. PAYMENT. Players will not be permitted to play until their entry fee is paid. Players must also be registered as a junior with WA Squash.
4. THE DRAW. All players must be available to play from 9am Sunday 21 Feb and any other time specified during the Tournament. The draw will be completed and posted on the WA Squash website by 4pm Friday 19 Feb. All players must be present 15 minutes prior to scheduled start time. Late players and entries may not be accepted.
5. BALLS. Dunlop double yellow, Pro balls will be used for all divisions. Dunlop Progress balls may be used at the discretion of the tournament committee for the lower divisions.
6. EVENTS. All events shall be the best of 5 games point a rally to 11. Each competitor will play a minimum of 3 matches.
7. PROTECTIVE EYEWEAR. All juniors must wear **Approved Protective Eyewear** whilst on court irrespective of whether they are competing in a match or just practising. Non-compliance with this may result in the player being defaulted from the tournament. Eyewear will be available to hire/buy if needed.
8. PRESENTATIONS. All players receiving prizes/trophies shall attend the presentation ceremony. Any player not attending must make collection arrangements with the tournament organisers or may forfeit their award.
9. ELIGIBILITY OF PLAY. You must register and pay your entry to be eligible to play. All players must be at the courts 15 minutes before scheduled start time; failure to do so **will** result in the forfeiting of your match.
10. The tournament organisers, WA Squash and its officers, employees or agents shall not be liable for any death or personal injury or loss or damage to property sustained or incurred by any person in connection with the tournament however caused.
